Since Denmark distorts competition by not actively directing customers to the cheapest electricity (Belgium), then Denmark is in violation of ANITRUST laws within EU and in Denmark and I suspect, that ENOVOS are too rich to not wanting more business and also not opening its door for sales to customers outside (cross-border) Luxembourg.

When did outside national border become not cross-border.

I take it face value, that ENOVOS does not sell to countries in which ENOVOS is not represented with a company based in the respective country registered as a company in the respective country under that country's laws. Is it true, that ENOVOS is registered in France and Germany as a French and German company (which then leads to the obvious conclusion, that ENOVOS Luxembourg is not selling to French and German customers)?

If you are so kind as to direct me to the whereabouts of the information you have, that says ENOVOS (and similar companies) cannot sell outside national borders. I would be much oblided.

Would ENOVOS consider import-tax and V.A.T. added to cross-border purchases (of electric) as being in violation of ANTITRUST laws in The European Union?
